

# INDIVIDUALIZED CONSTITUTIONAL HOMEOPATHIC MANAGEMENT OF WART: A CASE STUDY

**Abstract:** Warts are benign tumors caused by DNA Human Papilloma Virus. Treatment must be started as soon as possible as the patient may suffer from cosmetic disfigurement with pain & remains as a potent source of transmission to others. Treatment requires various oils and ointment costing heavily to patient and sometimes even needs cauterization. Homoeopathic drugs on the other hands are cost effective, safe & with no side effects. Old female patient with 78 years of age was treated for multiple warts, one large below left nostril treated with Nitric Acid 30c followed by 200c. The paper represents systematic investigations and treatment for curing warts. The results indicate that, single medicine has effective role in treatment of wart with priority to the general symptom of patient, by considering the holistic approach towards patient.

#### Introduction:

warts are benign proliferation of skin & mucosa caused by human Papilloma virus (HPV). Currently more than 100 types of HPV have been identified. Certain HPV types tend to infect at particular anatomic sites, however warts of any HPV type may occur at any site. Primary clinical manifestation of HPV infection includes common warts, genital warts, flat warts. Less common manifestation of HPV infection includes focal epithelial hyperplasia. The diagnosis is based on clinical manifestation & usually straight forward by visual inspection, cosmetic embarrassment & risk of malignancy. Though sometimes it is a selflimiting disease but on average it takes about 01-02 years of resolution during which affected person suffers from cosmetic disfigurement, thus it is essential to get rid of disease as soon as possible. The detailed case report of female patient, strategy of treatment, medicines prescribed and achieved results are presented in coming sections.

**Case Report:** A 78-year-old female vegetarian, retired as clerk by profession, belonging to middle

socioeconomic family residing in urban area visited to our OPD on 21<sup>st</sup> June 2022 at Bharati Vidyapeeth Homoeopathic Medical College Pune with complaints of multiple warts one large below left nostril, various small behind left ear and some flat warts at abdomen and at back for four months. Patient has noticed that wart below left nostril started increasing day by day and raised to 07mm diameter. Patient was suffering from H.T. and lumbar spondylosis and was on Ayurvedic treatment.

Associated Complaints: Tearing pain in lower limbs, slight exertion causes weakness.

**History of Present Complaints:** Patient was under ayurvedic treatment for H.T. and Lumbar spondylosis. Suddenly patient noticed that warts are rising behind left ear, at abdomen and at back, one large wart increasing rapidly below left nostril. No any causation identified.

**Treatment History:** Ayurvedic treatment for H.T. and Spondylosis.




Fig 1. Repertorisation by Radar Synthesis

### 9.0 Predominant Miasm: Psorasycosis

**Repertorisation:** As generals were marked along with particulars, the case is repertories with the help of Synthesis repertory version 9.0 (Figure) **Selection of Remedy:** Nitric acid was selected on the basis of Repertorisation by considering the symptom similarity.

Selection of Potency: Nitric acid 30 two doses at start

**Justification of repetition of doses:** It has been done when required according to the principle.

Methodology followed for Treatment Plan, Selection of Medicine, Potency, Doses, and

**Repetition:** The patient has to go for 11 follow ups after initial diagnosis from June 2022 to

December 2022. Patient was prescribed with only one medicine Nitric acid. According to

Repertorisation Sulphur and Calcarea with few others were suggested. Based on case similarity (Aph 26 & Aph 147) and on the basis of constitution of patient, Nitric acid was selected. Repetition of doses were given (Aph 245-251) as per the guideline of our master Dr. Samuel Hahnemann. The initial dose was started with 30c

potency. After 02 months of observation the potency was increased to 200c for better results. Placebo was given as supplementary medicine. There was no appearance of new wart and old warts got completely vanished. General management advised was:

- 1. Do not touch the wart.
- 2. Don't try to pluck it.
- 3. Don't Apply any ointment.




Fig 2. At the time of clinical diagnosis.
