The cricket legend Sachin Tendulkar, along with other cricket and Bollywood celebrities, supported the government in its pushback against the support of numerous international celebrities for the farmers' agitation against new farm laws. Many Keralites, including his followers, denounced their "God" and agreed with Maria Sharpova's earlier remark. After saying in an interview that she didn't recognize Sachin Tendulkar, the Russian tennis player ran afoul of Malayalees in 2015. But, many have returned to her wall since Wednesday, expressing regret for their "crude behaviour" from six years ago. "The official handle of the BJP has put out something that I cannot speak out in the open," MDMK leader Vaiko stated. They ought to publicly apologies for defaming Periyar with a baseless charge. I never imagined they would descend to this level; the post needs to be taken down right away," he remarked. Unexpectedly, the BJP's allies PMK and AIADMK also denounced the post. S. Ramadoss, the founder of PMK, described the BJP's remark as "disgusting" on Twitter. "The post on Periyar on his anniversary by the BJP and their IT wing is abhorrent. This reveals their bilious eyes. This behavior is deplorable on multiple levels, he wrote.

"We deleted the tweet at the request of our party leaders and allies. We haven't added anything new; DMK party founders Anna and Kalaignar have made similar statements in the past." The vision of the Dravidian patriarch set the ground for the ascent of leaders like MG Ramachandran, CN Annadurai, and M. Karunaidhi. Thol Thirumavalvan, the founder and president of Tamil Nadu's VCK, tweeted a picture of the party and national flags, which sparked a debate online since some users said it contained "secessionist" undertones. The state's ruling DMK has the support of the VCK in elections. Thirumavalavan tweeted a video of his party members erecting the party flag a few days ago, writing in Tamil:

"Our movement's flag today! Our national flag tomorrow! #Tamilsflag #VCKflag However, a number of social media users took issue with Thirumavalavan's remark. One person remarked that raising one's party flag is perfectly OK and their right, but "why is that national flag?" Others argued that a national flag and a party flag shouldn't be compared in the incorrect way. In a tweet, political expert Sumant Raman stated: "In Tamil Nadu, there is a constant undercurrent of separatist in the rhetoric and deeds of several parties. For fear of the law, they are afraid to do it out in the open, although it is happening all the time. And this is coming from a lawmaker.



DMK Rajya Sabha member N. Kanimozhi appeared to be referred to as a "illegitimate child" in a couple of tweets posted by BJP national secretary H Raja, which caused a hornet's nest online. At a press conference, Tamil Nadu Governor Banwarilal Purohit patted the cheek of a prominent female journalist, to which Kanimozhi had responded angrily. Despite the fact that Purohit has since apologised, Kanimozhi expressed her displeasure by tweeting, "Even if the intention is above suspicion, a person who holds a public office has to understand that there is a decorum to it and violating a woman journalist's personal space does not reflect the dignity or the respect which should be shown to any human being. Raja tweeted a few

times in reaction to Kanimozhi. The first one questioned whether the media would interrogate a senior leader with the same rigor they did the governor. The daughter of DMK leader M Karunanidhi is Kanimozhi.

Could reporters interrogate a leader, an illegitimate child born of an illegitimate relationship, and a Rajya Sabha MP in the same manner as they questioned the governor, he questioned? No. The memories of Chidambaram Udaykumar, Anna Nagar Ramesh, and Perambalur Sadiq Basha will serve as a deterrent. The guys whose last names he cited were said to have been killed by Karunanidhi and his family in exchange for cooperating with various inquiries into them. The same family that murdered a student at Annamalai University for highlighting the issue was upset today, he added, adding that it was odd that someone who hadn't even completed class 10 used the prefix Dr. The DMK and senior Congress politician P Chidambaram responded to Raja's tweets, saying that there was no such thing as an "illegitimate child" and that the DMK welcomed comments on them. Raja had no reason to criticize Karunanidhi in that way because the latter had acknowledged Kanimozhi as his daughter on the Assembly floor, according to DMK leader RS Bharathi.
